Valid Arguments in Propositional Logic

Definition

- An argument in propositional logic is a sequence of propositions. All but the final proposition in the argument are called premises and the final proposition is called the conclusion.
- An argument is valid if the truth of all its premises implies that the conclusion is true.
- An argument form in propositional logic is a sequence of compound propositions involving propositional variables.
- An argument form is valid if no matter which particular propositions are substituted for the propositional variables in its premises, the conclusion is true if the premises are all true.
- The conclusion is true if the premises are all true

Valid Arguments in Propositional Logic

Definition

- An argument in propositional logic is a sequence of propositions. All but the final proposition in the argument are called premises and the final proposition is called the conclusion.

- An argument form is valid if no matter which particular propositions are substituted for the propositional variables in its premises, the conclusion is true if the premises are all true.

Argument Form

Example

 $(p \rightarrow q) \land p \longrightarrow q$, or

$$\left(\begin{array}{c} p \to q \\ p \\ \therefore q \end{array}\right)$$

- The validity of an argument follows from the validity of the form of the argument.
- (a) When both $p \rightarrow q$ and p are true, then q must also be true.
- We say this form of argument is true (i.e the conclusion must also be true) whenever all its premises (all statements in the argument other than the final one, the conclusion) are true,

Rules of Inference for Propositional Logic

- We make all premises true: $p \rightarrow q = T, P = T$
- 2 See in the table where is p = T and $p \rightarrow q = T$. You see it in the raw 1 so this is the critical row.
- Now see what about the conclusion? The conclusion is true, Therefore, the argument is valid.

Solution

put all premises true:

 $p \rightarrow q = T$ $\neg p = T$, then p = FNow, put q = T. So, we still have $p \to q = T$, but q = T, Then $\neg q = F$. The conclusion is False whereas all premises are true, Therefor, the argument is invalid.

put all premises true: $(p \rightarrow q) = T$ $q \to (p \to r) = T$ p = TSince p = T and $(p \rightarrow q) = T$, then q = TNow, since q = T and $q \to (p \to r) = T$ then $Q := (p \to r) = T$ We have p = T and $(p \rightarrow r) = T$ then r must be true. Therefore r = T and the argument is valid.
