Course description

The course is an introduction to corporate finance and provides a framework for analyzing investment and financial decisions of corporations. The course is also an introduction to capital budgeting, capital structure, cost of capital, and dividend policy. The focus is on fundamental principles of modern financial theory, so the approach is rigorous and analytical.

Methodology

We will use lectures, case discussions, excel practice classes and overview of some applications to topics of financial analysis.

Course objectives

- Evaluate the role of the Corporate Finance Manager
- Demonstrate the ability to evaluate investment decisions using a variety of appraisal techniques
- Explain and describe the different elements of working capital
- Describe and calculate the cost of capital for a business
- Describe and evaluate the main sources of business finance
- Examine the factors that determine a company's dividend policy

Exams and Grading

Exams

There will be three <u>unified multiple-choice exams</u>: Two midterm exam and a final exam. There will also be two non-unified quizzes.

The first mid-term exam will cover chapters 9, 10, 13

The second mid-term exam will cover chapters 11, 15, 16

The final exam will be a cumulative test.

The first quiz will cover chapters 9, 10 and 13, whereas the second quiz will cover chapters 11, 15 and 16.

You are not allowed to refer to textbook or class notes during the exams.

If you miss an exam without any prior permission, you will be given a grade of zero. Make up exams are available only for officially documented cases.

Exam Regulations

• Students are NOT allowed to TALK to each other during the exam.

- Students are NOT allowed to BRING their Electronic devices, Bags, and Sunglasses into the examination room.
- Students must SHOW their photo IDs and SIGN the attendance sheet.
